A minimum of 73 hours to graduate; Application fee \$75
Designation must be completed within 5 years of application

LEVEL 100 – CORE COMPETENCIES

Mandatory 18 Credit Hours Required

Competency courses are taken **OnDemand/Online** and can be accessed anytime, on your own and at your own pace and schedule. Must complete all core courses but not required before taking a live course. Courses taken within 6 months of applying for the GRI program will count.

LEVEL 200 – MARKET KNOWLEDGE

Mandatory 20 Credit Hours Required; 12 Elective Hours

In level 200, the GRI course will touch on legal, legislative issues and the commercial side of real estate. You will gain one of three choices of a NAR Designation.

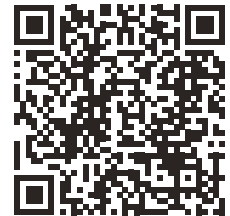
FINAL STEP AFTER GRI COMPLETION
